- 1. The user has to log into <u>www.adraccess.co.za</u> to start the process.
- 2. Once logged into the website the user has to click on the **<u>REGISTER NOW</u>** button.



3. The user then has to select the capacity (individual/entity) under which they would like to register a profile.
